He asked if there were any way to prevent the small rocks from being on the edge of the roadway following the winter season. Mark Doerfler explained the reason for the salt/gravel mix for winter road treatment as a cost reduction effort. The use of the mixture reduces the amount of salt needed and results in significant cost savings for the township.

Road Commissioners Report

Commissioner Doerfler reported the following:

- The old pick up was sold for \$1000, after auction fees the Road District made \$685.
- The new pick up should be in anytime.
- The Road District is cutting limbs following the wind storm.
- Some residents have requested the Road District to use the chipper to remove their tree limb piles. Unfortunately this cannot be done.
- Crack fill process is planned for portions of Darin Rd, Higgins Rd, Benson, School Dr., Dwight Rd and West Old Pine Bluff Rd. This is estimated to require 16,946 feet of paint and 11,523 feet of crack fill.
- Salt /sand use for the winter was as follows: 175 ton salt and 283 ton of sand.
- Whitetie Rd. repair is planned. Estimated cost is \$20,000 for replacement of 200 feet of roadway.
- An ash tree survey is planned. The tree locations will be mapped using GPS coordinates.


