#### Supervisor's Report

Supervisor Fannin reported the following:

- The new payroll services company is causing some difficulties as the process goes along. The use of the different town funds has been an issue as well as timeliness and communication.
- The MTAD met on June 13 with the newly appointed deputy Assessor. One of the four required classes was completed with the next one scheduled in August.
- An increase in the tax levy by the MTAD is anticipated in December. This is necessary due to the additional work required by the County.
- Approximately \$16,000 is available for this year with \$9,500 used for the Assessor's salary, with the remainder for TORMA and other expenses.
- The MTAD will be developing a plan for funding the future years needs in early October.

#### Road Commissioner's Report

Commissioner Doerfler reported the following:

- Southard Road work is complete except for the striping. The new striping material lasts about 20 years.
- Road crack fill will begin soon.
- Tree work is in progress. Some tree removal forms will be needed.
- The truck #4 has been refurbished.

- The parking lot at 20 E Southmor Rd has been repaved.
- Work will begin on the Web site improvements for the visually impaired.
- Starmmcom system of communication with other governmental groups installed.
- All trucks annual service has been completed.
- The John Deer tractor needed a new injection pump.
- The grader needs a new head gasket.
